RESOLUTION ESTABLISHING THE ENHANCED BARANGAYS HOUSEHOLD INVENTORY DATA ASSESSMENT (E-BHIDA) IN THE CITY OF SORSOGON AND THEREBY AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ISSUE DAILY ALLOWANCE IN THE AMOUNT OF ONE HUNDRED (P100.00) PESOS FOR PERSONNEL WHO WILL CONDUCT MONITORING, VALIDATION AND ASSESSMENT OF THE PROGRAM UNTIL THE DURATION THEREOF

**WHEREAS**, the Enhanced Barangays Household Inventory Data Assessment (E-BHIDA) is a tool to provide the city government a comprehensive information or data of every household in the each and every barangay to include some personal information of the members thereof;

**WHEREAS**, the Enhanced Barangays Household Inventory Data Assessment (E-BHIDA) is in consonance to the SELFIE Program under the 11 Point Agenda of the present administration

wherein a resident ID is a valid and sufficient document for the issuance and availment of all city government services;

**WHEREAS**, the program aims to collect data of every household and members thereof, for legal and official purposes, such as age, gender, employment, health/medical conditions and other information that would be the basis of the city government's purchases and procurements for the delivery of basic social services to its constituents such as but not limited to medicines, educational materials, health equipment and facilities, livelihood programs, nutrition supplements, pabahay and relocation programs, "Groupie" and "Sustenir" programs and other social services the city government could offer;

**WHEREAS**, E-BHIDA shall be the official instrument for identification of HH Hazards through geographical coordinates and/or establishment of Geographic Information System (GIS) hazard mapping as part of disaster preparedness and mitigation efforts of the city government of Sorsogon;

**WHEREAS**, the system could also provide a ready reference for the number of target recipients of the approaching mass vaccination against Covid 19 and all other similar undertakings wherein a comprehensive household inventory and data assessment are necessary;

**WHEREAS**, the Local Chief Executive shall have the authority to issue daily allowance in the amount of One Hundred (P100.00) Pesos for personnel who will conduct monitoring, validation and assessment of the program until the duration thereof;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolve as it is hereby resolved to establish the Enhanced Barangays Household Inventory Data Assessment (E-BHIDA) In the City of Sorsogon and thereby authorizing the Local Chief Executive to issue daily allowance in the amount of One Hundred (P100.00) Pesos for personnel who will conduct monitoring, validation and assessment of the program until the duration thereof.
