RESOLUTION DECLARING VALID BARANGAY TAX ORDINANCE NO. 01, SERIES OF 2020 FROM THE BARANGAY COUNCIL OF BARANGAY BALETE, BACON DISTRICT, SORSOGON CITY ENTITLED "THE NEW REVENUE TAX CODE OF BARANGAY BALETE, BACON DISTRICT, SORSOGON CITY"

WHEREAS, Barangay Tax Ordinance No. 01, Series of 2020 from the Barangay Council of Barangay Balete, Bacon District, Sorsogon City was among the items deliberated upon by the 7th City Council during the January 5, 2021 Regular Session and was officially referred to the Committee on Rules and Internal Affairs;

WHEREAS, cursory reading of the submitted barangay tax ordinance reveals that the said barangay tax ordinance is within the ambits of the powers conferred to the barangay council by virtue of Section 152 of Republic Act 7160 otherwise known as the Local Government Code of 1991.

WHEREAS, the Sangguniang Panlungsod finds the barangay tax ordinance intra vires as mandated by the Local Government Code of 1991;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution declaring valid Barangay Tax Ordinance No. 01, Series of 2020 from the Barangay Council of Barangay Balete, Bacon District, Sorsogon City entitled "The New Revenue Tax Code of Barangay Balete, Bacon District, Sorsogon City";
