RESOLUTION RECOMMENDING THE APPROVAL OF THE APPLICATION FOR RELEASE ON RECOGNIZANCE OF ALLAN LEGASPI TORALDE, ACCUSED, FILED AT THIS HONORABLE COURT, REGIONAL TRIAL COURT, BRANCH 52, FIFTH JUDICIAL REGION, SORSOGON CITY

WHEREAS, the Sangguniang Panlungsod, Sorsogon City was furnished with the notice, receipt thereof of the Sangguniang Panlungsod dated January 26, 2021, from this Honorable Court vis a vis the application/motion for the release of the accused on recognizance as embodied in Republic Act 10389 under Criminal Case No. 2020-11515 For: Violation of Secs. 5 & 11, Art. II of R.A. 9165;

WHEREAS, on occasion of the Regular Session of the City Council on February 9, 2021 after deliberations, the august body firmly believes that the applicants deserve compassion, being that they are indigents and anchored on the maxim that “those who have less in life must have more in law” and that they be released on recognizance to the custody of a qualified resident of El Refugio, Barangay Pangpang, West District, Sorsogon City or to any qualified resident of Sorsogon City, as the case maybe, pursuant to R.A. No. 10389, upon compliance of the requirements set forth thereunder;
