RESOLUTION AMENDING RULE V, SECTION 1 OF THE PARLIAMENTARY RULES AND PROCEDURE OF THE 7th SANGGUNIANG PANLUNGSOD OF THE CITY OF SORSOGON AND THEREBY CREATING THE COMMITTEE ON SENIOR CITIZENS AFFAIRS AS AN ADDITIONAL STANDING/REGULAR COMMITTEE THERETO

WHEREAS, similar to any deliberative body, the Sangguniang Panlungsod of the City of Sorsogon will successfully and expeditiously conduct its proceedings thru adherence to a set of rules that serves as a guide in its effective and orderly discussion which in effect will protect and preserve the dignity of this body;

WHEREAS, pursuant to Section 50 of the Local Government Code of 1991, the Sangguniang Panlungsod of the City of Sorsogon is authorized to adopt its own Internal Rules of Procedure for the effective and proper discharge of its legislative functions;

WHEREAS, the sector of Senior Citizens, being considered as one of important pillars of our society deserves to have an independent standing Committee in the Sangguniang Panlungsod to cater the needs and help to resolve issues concerning the sector of elderlies;

WHEREAS, Section 1 of Rule V of the Parliamentary Rules and Procedure of the 7th Sangguniang Panlungsod of the City of Sorsogon, shall have an additional regular committee, to wit:

COMMITTEE ON SENIOR CITIZENS AFFAIRS

- All matters pertaining to projects, programs, activities and all such other measures relative to the upliftment of the condition of the Senior Citizens.
- All matters pertaining to direct and indirect actions of the sector concerning their political and socio-economic growth.
- All matters relating to the welfare and development of the sector and the implementation of the constitutional provisions and other laws for Senior Citizens.

WHEREAS, the committee shall be composed of a chairman, a vice chairman and not more than three (3) members as prescribed under Section 2 of Rule V of the Parliamentary Rules and Procedure of the 7th Sangguniang Panlungsod of the city of Sorsogon.

NOW THEREFORE, on motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by **Hon. Nestor J. Baldon**, resolve as it is hereby resolved to amend Rule V, Section 1 of the Parliamentary Rules and Procedure of the 7th Sangguniang Panlungsod of the city of Sorsogon and thereby creating the Committee on Senior Citizens Affairs as an additional standing/regular committee thereto.
