RESOLUTION DECLARING VALID BARANGAY ORDINANCE NO. 01, SERIES OF 2021 FROM THE BARANGAY COUNCIL OF BARANGAY CAMBULAGA, WEST DISTRICT, SORSOGON CITY ENTITLED "AN ORDINANCE IMPOSING A LIQUOR BAN IN EVACUATION CENTERS IN TIMES OF CALAMITIES"

WHEREAS, Barangay Ordinance No. 01, Series of 2021 from the Barangay Council of Barangay Cambulaga, West District, Sorsogon City was among the items deliberated upon by the 7th City Council during the February 9, 2021 Regular Session;

WHEREAS, cursory reading of the submitted barangay ordinance reveals that the said barangay ordinance is within the ambits of the powers conferred to the barangay council by virtue of Chapter 4, Section 391 of Republic Act 7160 otherwise known as the Local Government Code of 1991.

WHEREAS, the Sangguniang Panlungsod finds the barangay ordinance intra vires as mandated by the Local Government Code of 1991;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution declaring valid Barangay Ordinance No. 01, Series of 2021 from the Barangay Council of Barangay Cambulaga, West District, Sorsogon City entitled "An ordinance imposing a liquor ban in evacuation centers in times of calamities";

NOW THEREFORE, on motion of **Hon. Joven G. Laura** duly seconded by **Hon. Rebecca D.
