RESOLUTION DECLARING VALID BARANGAY ORDINANCE (RESOLUTION NO. 03, SERIES OF 2021) FROM THE BARANGAY COUNCIL OF BARANGAY CAMBULAGA, WEST DISTRICT, SORSOGON CITY ENTITLED "A RESOLUTION AMENDING BARANGAY TAX ORDINANCE SERIES OF 2015 AND INCREASE FEES AND CHARGES WITH SPECIFIC CONCERNS"

**WHEREAS**, Barangay Ordinance (Resolution No. 03, Series of 2021) from the Barangay Council of Barangay Cambulaga, West District, Sorsogon City was among the items deliberated upon by the 7<sup>th</sup> City Council during the February 9, 2021 Regular Session;

**WHEREAS**, cursory reading of the submitted barangay tax ordinance reveals that the said barangay tax ordinance is within the ambits of the powers conferred to the barangay council by virtue of Section 152 of Republic Act 7160 otherwise known as the Local Government Code of 1991.

**WHEREAS**, the Sangguniang Panlungsod finds the barangay tax ordinance intra vires as mandated by the Local Government Code of 1991;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution declaring valid Barangay Tax Ordinance (Resolution No. 03, Series of 2021) from the Barangay Council of Barangay Cambulaga, West District, Sorsogon City entitled "A Resolution Amending Barangay Tax Ordinance Series of 2015 and increase fees and charges with specific concerns";
