RESOLUTION APPROVING AND ADOPTING THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT PLAN (LDRRMP) FUNDED UNDER THE NATIONAL DISASTER RISK REDUCTION MANAGEMENT FUND (NDRRMF) AMOUNTING TO TWENTY EIGHT MILLION ONE HUNDRED FORTY-EIGHT THOUSAND NINE HUNDRED SEVENTY-THREE PESOS (\$\frac{1}{2}28,148,973.00\$) PESOS
