RESOLUTION AUTHORIZING HON. CITY MAYOR MA. ESTER E. HAMOR TO ENTER INTO A CONTRACT OF AFFILIATION WITH THE SORSOGON STATE COLLEGE REPRESENTED BY ITS PRESIDENT DR. HELEN R. LARA

WHEREAS, the Sangguniang Panlungsod is in receipt of Transmittal No. 06, Series of 2021, dated February 10, 2021 with a draft of Contract of Affiliation by and between the city government of Sorsogon and the Sorsogon State College (SSC) relative to the conduct of Affiliation Training of their Midwifery Students;

WHEREAS, the agreement entered into by and between the parties shall govern the training of students at designated facilities identified by the City Health Office;

WHEREAS, considering the current situation of the country and our concerted efforts to strengthen our manpower in our continuing battle against the pandemic, the city government is supportive to the aforesaid noble undertaking;

WHEREAS, the city government shall allow the affiliation and training of Midwifery students of the SSC subject to the policies, procedures and guidelines governing affiliation and training of students in the DOH/Rural Health Units and other Health Agencies;

WHEREAS, the SSC is expected to strictly comply with the provisions of the Contract of Affiliation and Administrative Order No. 5-A, Series of 1996;

NOW THEREFORE, on incidental motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by **Hon. Rebecca D. Aquino**, resolve as it is hereby resolved to authorize Hon. City Mayor Ma. Ester E. Hamor to enter into a Contract of affiliation with the Sorsogon State College represented by its President Dr. Helen R. Lara.
