RESOLUTION INTERPOSING NO OBJECTION TO THE IMPLEMENTATION OF PIPE REPLACEMENT ACTIVITY IN VARIOUS BARANGAYS IN THE CITY OF SORSOGON BY THE SORSOGON CITY WATER DISTRICT IN PARTNERSHIP WITH PRIME WATER

WHEREAS, on January 26, 2021, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City issued Transmittal No. 03, series of 2021 addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Members of the 7th City Council respectfully requesting for the passage of a resolution interposing no objection to the implementation of pipe replacement activity in various barangays in the City of Sorsogon by the Sorsogon City Water District in partnership with Prime Water;

WHEREAS, the matter was jointly referred to the Committee on Public Utilities and the Committee on Infrastructure for further deliberation;

WHEREAS, on February 16, 2021, a Joint Committee hearing was conducted for the purpose inviting the presence of Prime Water, Sorsogon City Water District, representative from City Engineering Office and Members of the Joint Committee;

WHEREAS, per deliberation thereof, the intent and purpose of the aforementioned endeavor is to replace dilapidated pipe line in various barangays in Sorsogon City in order to avoid further water wastage and ensure quality potable water for water consumers;

WHEREAS, for purposes of this resolution and as agreed upon during the Joint Committee Hearing, hereunder are the commitment of the requesting party;

1. That Prime Water and Sorsogon City Water District complies with existing rules and regulations imposed by the City Engineering Office in relation to infrastructure development aspect;
2. That Prime Water and Sorsogon City Water District coordinate with Public Order and Safety Office for purposes of harmonized traffic related concerns;
3. That Prime Water and Sorsogon City Water District installs early warning devices and other safety concerns on areas where pipe replacement is being implemented;
4. That with knowledge and consent of Prime Water and Sorsogon City Water District, aggregates removed thereof be coordinated with the City Engineering Office for hauling purposes and be utilized for other purposes;
5. That Prime Water and Sorsogon Water District shall cause the immediate implementation of their project in order to avoid inconvenience to our residents and to uphold public safety.

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution interposing no objection to the implementation of pipe replacement activity in various barangays in the City of Sorsogon by the Sorsogon City Water District in partnership with Prime Water;

NOW THEREFORE, on motion of **Hon. Franco Eric O. Ravanilla** duly seconded by **Hon. Mary Ellen D. Jamisola** resolve as it is hereby resolved to interpose no objection to the implementation of pipe replacement activity in various barangays in the City of Sorsogon by the Sorsogon City Water District in partnership with Prime Water;

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance.
