**RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) AND DEED OF CONDITIONAL DONATION OF A PARCEL OF LAND WITHIN THE CITY HALL COMPLEX DESIGNATED AS LOT 14 OF THE SUBDIVISION SURVEY PSD-05-045231, IN FAVOR OF THE CIVIL SERVICE COMMISSION (CSC) REPRESENTED BY ITS CHAIRPERSON ALICIA DELA ROSA-BALA**

**WHEREAS**, the city government of Sorsogon has made prior commitments to various government agencies for the construction of the latter's respective offices within the vicinity of the city hall in Barangay Cabid-an, East District, Sorsogon City in order that the public can officially transact business with various government agencies in just one place within the city hall compound;

**WHEREAS**, the Civil Service Commission (CSC) is one of those agencies signified and expressed their intention to avail such opportunity;

**WHEREAS**, the Hon. City Mayor Ma. Ester E. Hamor requested the 7<sup>th</sup> City Council for the rectification of Resolution No. 126, Series of 2019 relative to the conditional donation of a parcel of land designated as Lot 8 of Subdivision Survey PSD-05-045231, being portion of Lot 4 Pcs-05-002072 in favor of the Civil Service Commission (CSC) represented by its Chairperson Alicia Dela Rosa-Bala;

**WHEREAS**, after further coordination with the CSC and the Provincial Government of Sorsogon, it was agreed that the area to be donated to the Commission shall be Lot 14 of the aforesaid subdivision survey to allow more access for the clients and stakeholders;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Joven G. Laura**, resolved as it is hereby resolve to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor to enter into a Memorandum of Agreement (MOA) and Deed of Conditional Donation of a parcel of land within the city hall complex designated as Lot 14 of the Subdivision Survey PSD-05-045231, in favor of the Civil Service Commission (CSC) represented by its Chairperson Alicia Dela Rosa-Bala;
