**RESOLUTION ENJOINING BARANGAY COUNCIL MEMBERS TO STRICTLY IMPLEMENT ROAD CLEARING OPERATIONS IN THEIR RESPECTIVE JURISDICTIONS AND TO IMMEDIATELY COORDINATE WITH SK3 AND PNP VIOLATIONS COMMITTED FOR PURPOSES OF ISSUANCE OF CITATION TICKETS**

**WHEREAS**, on July 29, 2019, the Department of Interior and Local Government issued Memorandum Circular No. 2019-121 addressed to all Provincial Governor, City and Municipal Mayors, Punong Barangays, Heads of Local, DILG Regional Directors, BARMM Regional Governor and all other concerned in relation to the Presidential Directive during the 4<sup>th</sup> State of the Nation Address of the President to Clear Roads of Illegal Structures and Construction;

**WHEREAS**, in consonance thereof series of memorandum circular was later issued by the Department of the Interior and Local Government reiterating compliance of the aforementioned by local government units wherein assessment thereof shall be conducted;

**WHEREAS**, the barangay government plays a vital role in achieving compliance of the herein mentioned directive from the president through coordination and collaboration with SK3 and the PNP;

**WHEREAS**, as regards to the manner of implementation of the intent and purpose of this resolution, parties herein mentioned through the intervention of the Liga ng mga Barangay convene and arrive with an effective and efficient scheme;

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution enjoining Barangay Council Members to Strictly Implement Road Clearing Operations in their respective jurisdictions and to immediately coordinate with SK3 and PNP violations committed for purposes of issuance of Citation Tickets;

Baldon**, resolve as it is hereby resolved to enjoin Barangay Council Members to Strictly Implement Road Clearing Operations in their respective jurisdictions and to immediately coordinate with SK3 and PNP violations committed for purposes of issuance of Citation Tickets;
