RESOLUTION DECLARING VALID BARANGAY ORDINANCE NO. 01, SERIES OF 2021 FROM THE BARANGAY COUNCIL OF BARANGAY BASUD, WEST DISTRICT, SORSOGON CITY ENTITLED "AN ORDINANCE PROVIDING FOR THE ECOLOGICAL SOLID WASTE MANAGEMENT PROGRAM, DECLARING CERTAIN PROHIBITED ACTS AND PROVIDING PENALTIES FOR VIOLATION THEREOF"

WHEREAS, Barangay Ordinance No. 61, Series of 2621 from the Barangay Council of Barangay Basud, West District, Sorsogon City was among the items deliberated upon by the 7<sup>th</sup> City Council during the February 23, 2021 Regular Session and was officially referred to the Committee on Rules and Internal Affairs;

WHEREAS, cursory reading of the submit barangay ordinance reveals that the concerned barangay council intends to enhance the barangay solid waste management program consistent

with the provisions under Republic Act 9003 otherwise known as the Ecological Solid Waste Management Act of 2000;

**WHEREAS**, said barangay ordinance in its entirety are within the powers and functions of the barangay to legislate pursuant to section 391 of the RA 7160;

**WHEREAS**, said barangay ordinance be implemented in consonance with relevant existing laws, rules and regulations;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution declaring valid Barangay Ordinance No. 01, Series of 2021 from the Barangay Council of Barangay Basud, West District, Sorsogon City entitled "An ordinance providing for the ecological solid waste management program, declaring certain prohibited acts and providing penalties for violation thereof"
