RESOLUTION DECLARING VALID BARANGAY ORDINANCE NO. 01, SERIES OF 2021 FROM THE BARANGAY COUNCIL OF BARANGAY SAN JUAN, EAST DISTRICT, SORSOGON CITY – RESOLUTION APPROVING THE NEW TAX ORDINANCE OF BARANGAY SAN JUAN, EAST DISTRICT, SORSOGON CITY SUBJECT TO THE EXCLUSION OF THE ISSUE ON BARANGAY WATER SYSTEM ADMINISTRATION AND IMPOSITION OF FEES AND CHARGES IN THE BARANGAY ORDINANCE

WHEREAS, Barangay Ordinance No. 01, Series of 2021 from the Barangay Council of Barangay San Juan, East District, Sorsogon City was among the items deliberated upon by the 7<sup>th</sup> City Council during the February 23, 2021 Regular Session and was officially referred to the Committee on Rules and Internal Affairs;

**WHEREAS**, cursory reading of the submit barangay ordinance reveals that the concerned barangay council intends to renew fees being imposed by the barangay and it presupposes therefore that there is actually an amendment to the previous (original) tax ordinance;

**WHEREAS**, said barangay ordinance is a valid exercise of the Barangay regulatory power granted by Republic Act 7160 otherwise known as the Local Government Code of 1991;

**WHEREAS**, the same be implemented in consonance with relevant existing laws, rules and regulations;

**WHEREAS,** one of the recommendations under Committee Report No. 027, Series of 2021, is the exclusion of the issue on barangay water system administration and imposition of fees and charges in the barangay ordinance and the same be forwarded to the Department of Interior and the Local Government (DILG) for proper disposition;

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution declaring valid Barangay Ordinance No. 01, Series of 2021 from the Barangay Council of Barangay San Juan, East District, Sorsogon City subject to certain conditions;

**NOW THEREFORE**, on motion of **HON. FRANCO ERIC O. RAVANILLA** duly seconded by **HON. JO ABEGAIL C. DIONEDA**, resolve as it is hereby resolved to declare valid Barangay Ordinance No. 01, Series of 2021 from the Barangay Council of Barangay San Juan, East District, Sorsogon City –Resolution Approving the New Tax Ordinance of Barangay San Juan, East District, Sorsogon City subject to the exclusion of the issue on barangay water system administration and imposition of fees and charges in the barangay ordinance.
