RESOLUTION ENJOINING ALL BARANGAY OFFICIALS, SK3 AND PNP TO BE VIGILANT IN THE STRICT IMPLEMENTATION OF THE MINIMUM HEALTH PROTOCOLS IMPOSED BY THE INTER AGENCY TASK FOR THE MANAGEMENT OF EMERGING INFECTIOUS DISEASES (IATF-MEID)

WHEREAS, just recently Metro Manila and other neighboring local government units recorded a sudden surge of COVID19 cases wherein such cases were confirmed by the Department of Health to include UK and South African variants;

WHEREAS, because of the sudden surge in COVID 19 cases in the Metropolitan Area, economic instability comes in wherein people tends to go home to their respective provinces instead of staying jobless, economically and financially unstable in Metro Manila Area;

WHEREAS, social media posts also reported modus operandi wherein passengers from other neighboring regions are being transported inside a closed van in order to avoid checkpoint somewhere in Del Gallego, Camarines Sur and once the passengers crossed and gets in the Bicol Region Area, passengers may now disembark and use other mode of usual transportation in returning to their respective Provinces;

WHEREAS, the use of private four wheel vehicles for a fee are also rampantly used to ensure that passengers will enter the borders of Bicol Region without need of required documents as imposed by the Inter Agency Task Force for the Management of Emerging Infectious Diseases (IATF-MEID);

WHEREAS, the record high thirty (30) COVID 19 Cases in the Province of Sorsogon in a single day wherein twenty four (24) of which comes from Sorsogon City dated April 3, 2021 can be attributed and connected to the preceding statements, thus preventive and mitigating approach is vital in order to protect the interest of our local constituents from COVID 19 transmissions brought about by returning passengers from nearby regional areas in Luzon;

WHEREAS, this alarming COVID 19 Health Bulletins needs to be addressed using the Grass Roots Level Approach wherein the barangay officials are called to actively participate in monitoring and recording of persons within their respective barangay jurisdictions who may be violating minimum health protocols such as mandatory use of face mask and social distancing, suspected of, arrived from other places just lately without proper documentation as required by Inter Agency Task Force for the Management of Emerging Infectious Diseases (IATF-MEID);

WHEREAS, in addition thereof, SK3 and PNP collaboration is of vital importance in order to achieve our common goal which is to defeat COVID 19 pandemic;

WHEREAS, the intent of purpose of this resolution drives on the principle that barangay officials can effectively monitor and identify persons suspected of, arrived from other places just lately without proper documentation as required by Inter Agency Task Force for the Management of Emerging Infectious Diseases (IATF-MEID), thus there is a need to report the same to the City Health Office for proper disposition;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution enjoining all barangay officials, sk3 and pnp to be vigilant in the strict implementation of the minimum health protocols imposed by the Inter Agency Task For The Management Of Emerging Infectious Diseases (IATF-MEID);

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Lorenz S. Abenion**, resolved as it is hereby resolve to enjoin all barangay officials, SK3 and PNP to be vigilant in the strict implementation of the minimum health protocols imposed by the Inter Agency Task For The Management Of Emerging Infectious Diseases (IATF-MEID).
