RESOLUTION ENACTING AN ORDINANCE SUSPENDING THE IMPLEMENTATION OF SECTION 58 OF CITY ORDINANCE NO. 22, SERIES OF 2020 IN RELATION TO FEES TO BE COLLECTED ON MTOP/MAYOR'S PERMIT IN THE AMOUNT OF TWO HUNDRED (P 200.00) PESOSO AND THE ACTUAL COST OF PERMANENT FRANCHISE PLATE NUMBER AMID COVID 19 PANDEMIC.

WHEREAS, tricycle transport group is considered among the marginalized sector of our society but plays a vital role in our economy championing people's mobility and accessibility;

WHEREAS, amid COVID 19 Pandemic, this sector is also among the hardly hit and suffered serious blows in terms of livelihood;

WHEREAS, at present, there are existing fees and charges imposed upon operation tricycle for hire units which includes MTOP/Mayor' Permit Fee and the actual cost of Permanent Franchise Plate Number pursuant to City Ordinance No. 22, series of 2021;

WHEREAS, as a gesture of support in this trying times, the local chief executive initiated a move to suspend the implementation of the aforementioned fees and was eventually submitted to the legislative department for the passage of an appropriate legislation;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to enact an ordinance suspending the implementation of Section 58 of City Ordinance No. 22, series of 2021 in relation to fees to be collected on MTOP/Mayor's Permit in the amount of Two Hundred (P 200.00) Pesos and the actual Cost of Permanent Franchise Plate Number amid COVID 19 Pandemic;

NOW THEREFORE, on motion of **City Councilor Nestor J. Baldon** duly seconded by **City Councilor Franco Eric O. Ravanilla**, resolve as it is hereby done to enact an ordinance suspending the implementation of Section 58 of City Ordinance No. 22, series of 2021 in relation to fees to be collected on MTOP/Mayor's Permit in the amount of Two Hundred (P 200.00) Pesos and the actual Cost of Permanent Franchise Plate Number amid COVID 19 Pandemic;

AN ORDINANCE SUSPENDING THE IMPLEMENTATION OF SECTION 58 OF CITY ORDINANCE NO. 22, SERIES OF 2021 IN RELATION TO FEES TO BE COLLECTED ON MTOP/MAYOR'S PERMIT IN THE AMOUNT OF TWO HUNDRED (P 200.00) PESOS AND THE ACTUAL COST OF PERMANENT FRANCHISE PLATE NUMBER AMID COVID 19 PANDEMIC;

BE IT ORDAINED BY THE 7TH CITY COUNCIL OF SORSOGON IN SESSION ASSEMBLED THAT:

SECTION 1 SHORT TITLE

This ordinance shall be known as **"TRICYCLE FOR HIRE TO RECOVER AS ONE ORDINANCE OF 2021"**

SECTION 2 DECLARATION POLICY

It is hereby the policy of the City Government of Sorsogon to promote harmonious relationship among the tricycle transport sector particularly in this trying times. The City Government of Sorsogon also recognizes their role in our society's mobility locally used as the usual mode of transportation

Further, the Local Government Unit of Sorsogon, through the 7TH City Council shares common ground in our battle to outdo and surpass effects of COVID 19 Pandemic economically.

SECTION 3 SCOPE AND COVERAGE

This ordinance shall include all tricycle for hire in the territorial jurisdiction of the City of Sorsogon;

SECTION 4 SUNSET PROVISIONS

This ordinance shall be effective until a New Normal is declared by appropriate authorities through the City health Office.

SECTION 5 SEPARABILITY CLAUSE

If for any reason, any provision or provisions of this ordinance be held unconstitutional or declared invalid, other provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 6 REPEALING CLAUSE

All ordinances, rules and regulations in conflict with and/or inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 7 EFFECTIVITY CLAUSE

This ordinance shall take effect immediately upon its approval.
