RESOLUTION TEMPORARILY TRANSFERRING THE BACON BIRTHING FACILITY TO THE ST. THERESE HOSPITAL COMPOUND PENDING THE RENOVATION OF THE RURAL HEALTH UNIT AT POBLACION, BACON DISTRICT, SORSOGON CITY

WHEREAS, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City on its letter dated May 10, 2021, addressed to Hon. City Vice Mayor Mark Eric C. Dioneda and to the honorable members of the 7th City Council, requested to pass a resolution temporarily transferring the Bacon Birthing Facility to the St. Therese Hospital Compound pending the renovation of the Rural Health Unit at Poblacion, Bacon District, Sorsogon City.;

WHEREAS, this resolution is among the requirements for the City Health Office to secure permit to construct and license to operate so as not to deprive the residents of Bacon District with the services of the birthing facility;

WHEREAS, the name of the facility shall remain as the CHO Bacon Birthing Facility;
