RESOLUTION TEMPORARILY TRANSFERRING THE BACON BIRTHING FACILITY TO THE ST. THERESE HOSPITAL COMPOUND PENDING THE RENOVATION OF THE RURAL HEALTH UNIT AT POBLACION, BACON DISTRICT, SORSOGON CITY

**WHEREAS**, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City on its letter dated May 10, 2021, addressed to Hon. City Vice Mayor Mark Eric C. Dioneda and to the honorable members of the 7<sup>th</sup> City Council, requested to pass a resolution temporarily transferring the Bacon Birthing Facility to the St. Therese Hospital Compound pending the renovation of the Rural Health Unit at Poblacion, Bacon District, Sorsogon City.;
