## Resolution No. 159, Series of 2021

RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO PREPARE AND SIGN A NEW DEED OF DONATION TO THE SAME BENEFICIARIES OF THE PABAHAY PROGRAM AT BARANGAY BUENAVISTA, WEST DISTRICT, SORSOGON CITY

WHEREAS, after perusal made by the Joint Committee on Laws, Justice and Human Rights and the Committee on City Properties, it was found out that some of the Deed of Donation made and executed by the previous administration to recipients of a relocation site located at Barangay Buenavista, West District were received by the latter after the incumbency of the former administration and some were left unsigned by the donee;

**WHEREAS**, said predicament introduces legal implication especially when the matter has to be presented to national concerned government agencies charged with the processing of the aforementioned instruments;

**WHEREAS**, in order to remedy the foregoing predicament and as required by appropriate national government agencies concerned, a new Deed of Donation by and between the incumbent local chief executive is vital for purposes of processing and the eventual titling of lots at issue;

**WHEREAS,** for purposes of this resolution, the New of Deed of Donation as herein authorized shall cover all recipients previously issued identified by the previous administration;

**NOW THEREFORE**, on motion of **Hon. Hilario D. Dioneda**, duly seconded by **Hon. Ralph Walter R. Lubiano**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to prepare and sign a new Deed of Donation to the same beneficiaries of the Pabahay Program at Barangay Buenavista, West District, Sorsogon City;
