**RESOLUTION RESPECTFULLY REQUESTING THE LAND TRANSPORTATION OFFICE (LTO) - SORSOGON CITY FIELD OFFICE TO FACILITATE THE IMMEDIATE ACTIONS ON THE APPLICATIONS OR TRANSACTIONS INVOLVING TRICYCLE FRANCHISE ISSUED AND ACTED UPON BY THE SANGGUNIANG PANLUNGSOD, SORSOGON CITY**

**WHEREAS**, City Ordinance No. 22-2020 ("Sorsogon City New Tricycle Franchise Code of 2020") allowed the dropping/cancellation of Tricycle Franchise due to the demise of the holders thereof and thereby authorizing any member of the immediate family and priority/waiting applicants to substitute or replace the former to operate Tricycle-for-Hire in the City of Sorsogon under the same franchise, motorcycle unit and route of operation;

**WHEREAS**, Section 13 of City Ordinance No. 22-2020 ("Sorsogon City New Tricycle Franchise Code of 2020") provides:

**SECTION 13 VALIDITY OF FRANCHISE**

Any franchise shall remain valid for a period three (3) years from the date of its issuance and shall be renewed on its anniversary date. If the anniversary date falls on a Saturday, Sunday or holiday or on the occasion of declared calamity the renewal shall be on the next working day immediately after.

The inaction of the grantee for a period of six (6) months after the expiration of tricycle franchise shall cause an automatic revocation of the privilege granted after 2 (two) notices.

Within six (6) months from the death of the franchise holder, the Certificate of Franchise shall be surrendered to the Sangguniang Panlungsod through CTFRO. The surviving spouse or any of his/her children shall be the priority applicant for the said recalled franchise. Failure to report and surrender the said franchise within the prescribed period shall be forfeited in favor of the city government and may be awarded to qualified waiting applicant.

**WHEREAS**, the Sangguniang Panlungsod, by virtue of provisions under RA 7160, otherwise known as the Local Government Code of 1991, subject to the guidelines prescribed by the Department of Transportation and Communications has the power to regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the city.(RA 7160, Sec.458 (3)(vi));

**WHEREAS**, Republic Act 9485 otherwise known as the Anti-Red Tape Law (ARTA) of 2007 mandates all government offices to simplify frontline service procedures, formulate service standards to observe in every transaction and make known these standards to their clients;

**WHEREAS**, Republic Act No. 11032 otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 was enacted on May 28, 2018 amending Republic Act 9485 to provide a program for the adoption of simplified requirements and procedures that will reduce red tape and expedite business and nonbusiness related transactions in government;

**WHEREAS**, it is the objective of this measure to provide the tricycle transport sector and their families, continued economic opportunities and source of livelihood specially during this pandemic;


**NOW THEREFORE**, on incidental motion of **City Councilor Franco Eric O. Ravanilla**, duly seconded by **City Councilor Nestor J. Baldon**, resolved as it is hereby resolve to respectfully request the Land Transportation Office – (LTO) Sorsogon City Field Office to facilitate the immediate actions on the applications or transactions involving tricycle franchise issued and acted upon by the Sangguniang Panlungsod, Sorsogon City.

**RESOLVED FURTHER**, resolved further that copies of this resolution be furnished to all concerned for their information and guidance.
