RESOLUTION RESPECTFULLY REQUESTING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO CONDUCT ORIENTATION AND TRAINING PROGRAM FOR THE ADMINISTRATION AND PROPER ISSUANCE OF CITATION TICKETS IN VIOLATION OF COVID 19 MINIMUM HEALTH PROTOCOLS AND ALL OTHER APPLICABLE ORDINANCES OF THE CITY OF SORSOGON

WHEREAS, the measure aims to conduct orientation and training program for the administration and proper issuance of citation tickets in the enforcement of Covid 19 Minimum Health Protocols and all other ordinances with penal provision in order to achieve a systematic and orderly enforcement and apprehension of violators thereof;

WHEREAS, the measure further aims to establish a unified form of City Ordinance Violation Citation Ticket to be used by law enforcers of the City in citing individual or entity for violation of Covid 19 Minimum Health Protocols and any city ordinances with penal provision;

WHEREAS, it is further requested to formulate rules and regulations for the administration and proper issuance of citation tickets in violation of Covid 19 Minimum Health Protocols and all other applicable ordinances of the City of Sorsogon:

1. Issuance of commission to qualified officials or employees of the City Government who are at the frontline of enforcement of city ordinances, as well as the barangay officials and Tanods.
2. The training shall involve the following:
 - a. To avoid uttering of any kind of invective or personal insult or commission of any form of disrespect or arrogance.
 - b. Non-issuance of a violation citation ticket for non-existent violation.
 - c. How to effectively inform the person to be apprehended of the violation for which he or she is being apprehended.
 - d. The use of mandatory courtesy phrases such as "good morning/ afternoon/ evening, sir/ma'am", as the case maybe, "po", "opo", "tabi", or "ho" when addressing the person to be apprehended. In any event every person sought to be apprehended, without distinction, should be addressed as "sir" or "maam" as the case maybe.
3. To avoid committing patent tolerance of any violation by not apprehending any violation which is regularly recurring in his or her area of assignment.
4. The validity and revocation of the commission.
5. Establishment of data bank for violations of City Ordinances.
6. Establishment of a division at City Legal Office tasked to litigate violation of City ordinances.
7. Establishment of appropriate trust fund for the proceeds of fines for violation of City ordinances.
8. Provision of privileges to officials and employees tasked to enforce city ordinances.

WHEREAS, Section 5 of City Ordinance No. 13, Series of 2021 (Sorsogon City Emergency Curfew Ordinance of 2021 amid Covid 19 and Section 4 of City Ordinance No. 14, Series of 2021 (Mandatory wearing of face mask, face shields and observance of social/physical distancing ordinance of 2021), commissioned the barangay officials and their barangay tanods, PNP-Sorsogon City and the TMECS/SK3/Public Order and Safety Office to implement the aforesaid ordinances through the issuance of City Ordinance Violation Citation Ticket;

NOW THEREFORE, on incidental motion of **City Councilor Hon. Nestor J. Baldon** duly seconded by **City Councilor Danilo A. Deladia**, resolved as it is hereby resolve to respectfully request Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to conduct orientation and training program for the administration and proper issuance of citation tickets in violation of Covid 19 Minimum Health Protocols and all other applicable ordinances of the City of Sorsogon.
