## Resolution No. 166, Series of 2021

RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF EDUCATION (DepEd) REGIONAL OFFICE V RELATIVE TO THE UTILIZATION OF RAWIS ELEMENTARY SCHOOL AS VACCINATION SITE FOR BACON DISTRICT, SORSOGON CITY

WHEREAS, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City on its letter dated May 28, 2021, addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City and to the Honorable Members of the 7<sup>th</sup> City Council, requested to pass a resolution that will authorize her to enter into a Memorandum of Agreement (MOA) with the Department of Education (DepEd) Regional Office V relative to the utilization of Rawis Elementary School as vaccination site for Bacon District, Sorsogon City;

**WHEREAS**, the Memorandum of Agreement is relative to the intended use of Rawis Multi-Purpose Hall within the Rawis Elementary School premises as vaccination site for Bacon District;

**WHEREAS**, the area was identified by the City Health Office for the reason that the Rural Health Unit (RHU) in Bacon District does not have enough space required for mass vaccination against COVID 19;

**WHEREAS**, the old RHU Building which is presently used for the said purpose shall soon be demolished to give way to its renovation;

**WHEREAS**, the Department of Education is amenable of the utilization of the said area as a vaccination site provided that the city government shall enter into a MOA in which the duties and obligations of the parties shall be established for the purpose;

**NOW THEREFORE**, on motion of **City Councilor Mary Ellen D. Jamisola** duly seconded by **City Councilor Nestor J. Baldon**, resolved as it is hereby resolve to authorize Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Department of Education (DepEd) Regional Office V relative to the utilization of Rawis Elementary School as vaccination site for Bacon District, Sorsogon City.
