RESOLUTION ENJOINING THE 64 BARANGAY SK COUNCILS TO AVOID SPONSORING AND CONDUCTING ANY KIND OF CONTACT SPORTS AND OTHER SIMILAR ACTIVITIES DURING THE CELEBRATION OF BARANGAY FIESTA IN THE CITY OF SORSOGON

WHEREAS, while the state recognizes the vital role of the youth in the nation-building and the Constitution mandates the promotion of their physical, moral, spiritual, intellectual and social being, the barangay however, shall at all times have to obey and strictly implement the minimum health standards and protocol to combat Covid 19 Pandemic;

WHEREAS, the mandate of the State for the formulation, adoption and implementation of an integrated and coordinated youth development program which is responsive to the needs

and involvement of the youth in the affairs of the state, shall be temporarily set aside so as to implement the minimum public health protocols;

WHEREAS, the promotion of physical education and sports programs to foster self-discipline, teamwork and excellence for the development of a healthy and alert citizenry as mandated under Article XIV, Section 19 (1) of the 1987 Constitution, shall likewise be temporarily suspended as we implement measures to curtail the surge of Covid 19 active cases;

WHEREAS, amid the looming possibility of an uptick in cases of COVID-19, as well as the threat of the new variants the public shall be more vigilant in observing the minimum public health standards to prevent further transmission of the virus;

NOW THEREFORE, on motion of **Hon. Lorenz S. Abenion**, duly seconded by **Hon. Rebecca D. Aquino**, resolved as it is hereby resolve to enjoin the 64 Barangay SK Councils to avoid sponsoring and conducting any kind of contact sports and other similar activities during the celebration of Barangay Fiesta in the City of Sorsogon.
