RESOLUTION ENDORSING THE CONCRETING OF FARM TO MARKET ROAD (FMR) INFRASTRUCTURE PROJECT OF THE CITY GOVERNMENT OF SORSOGON AT SAN ISIDRO, WEST DISTRICT, SORSOGON CITY IN THE AMOUNT OF TWENTY MILLION PESOS (P20,000,000.00)TO THE DEPARTMENT OF BUDGET MANAGEMENT (DBM) FOR POSSIBLE FUNDING AND IMPLEMENTATION

WHEREAS, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City on its letter dated May 25, 2021, addressed to Hon. Mark Eric C.
