RESOLUTION ENDORSING THE ROAD REBLOCKING AND IMPROVEMENT OF DRAINAGE CANAL INRASTRUCTURE PROJECT OF THE CITY GOVERNMENT OF SORSOGON AT VARIOUS STREETS OF OUR LADY'S VILLAGE, BIBINCAHAN, EAST DISTRICT, SORSOGON CITY IN THE AMOUNT OF FIFTY MILLION PESOS (P50,000,000.00) TO THE DEPARTMENT OF BUDGET MANAGEMENT (DBM) FOR POSSIBLE FUNDING AND IMPLEMENTATION

WHEREAS, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City on its letter dated May 25, 2021, addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor, and to the Honorable Members of the 7th City Council, requested to pass a resolution that will favorably endorse the road reblocking and improvement of drainage canal infrastructure project of the City Government of Sorsogon at various streets of Our Lady's Village, Bibincahan, East District, Sorsogon City in the

amount of Fifty Million (P50,000,000.00) Pesos to the Department of Budget Management (DBM) for possible funding and implementation;
