RESOLUTION ENDORSING THE CONSTRUCTION/ REHABILITATION OF SALOG RIVER CONTROL INRASTRUCTURE PROJECT OF THE CITY GOVERNMENT OF SORSOGON AT SALOG, EAST DISTRICT, SORSOGON CITY IN THE AMOUNT OF FIFTY MILLION PESOS (P50,000,000.00) TO THE DEPARTMENT OF BUDGET MANAGEMENT (DBM) FOR POSSIBLE FUNDING AND IMPLEMENTATION

WHEREAS, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City on its letter dated May 25, 2021, addressed to Hon. Mark Eric C.
