RESOLUTION ACCEPTING THE RESIGNATION OF ATTY. JOVEN G. LAURA AS MEMBER OF THE 7TH CITY COUNCIL OF SORSOGON IN CONSONANCE WITH SECTION 82 OF REPUBLIC ACT 7160 OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, on June 01, 2021, the Office of the Secretary to the Sangguniang Panlungsod received the Letter of Resignation of Atty. Joven G. Laura as Member of the 7th City Council dated June 01, 2021;

WHEREAS, as contained in his letter, said letter of resignation is particularly sent to the Sangguniang Panlungsod in view of the regulations contained in Section 82 (a) (3) of Republic Act 7160 otherwise known as the Local Government Code of 1991 for acceptance so as not for him

to be charged of abandonment according to the provisions of Article 238 of the Revised Penal Code;
