## *Resolution No. 175, Series of 2021*

**RESOLUTION INTERPOSING NO OBJECTION ON THE APPLICATION FOR BUILDING PERMIT OF MR. BRUCE T. RECIDORO FOR THE CONSTRUCTION OF POULTRY HOUSE LOCATED AT BARANGAY SALVACION, BACON DISTRICT, SORSOGON CITY.**

**WHEREAS**, on May 05, 2021, Mr. Bruce T. Recidoro wrote a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor respectfully requesting for the passage of a resolution interposing no objection on his application for building permit for the construction of Poultry House located at Barangay Salvacion, Bacon District, Sorsogon City;

**WHEREAS**, attached to the aforementioned letter are as follows;

1. Certificate of Non Coverage (CNC-OL-RO5-2021-04-01044) ISSUED TO Mr. Bruce T. Recidoro dated April 29, 2021 for a Proposed Poultry House at Barangay Salvacion, Bacon, EMB, DENR Region V;
2. Certification issued to Mr. Bruce T. Recidoro dated March 11, 2021 issued by Mr. Alfonso L. Tayo, City Zoning Administrator;
3. Barangay Resolution No. 007, series of 2021 from the Barangay Council of Barangay Salvacion, Bacon District, Sorsogon City entitled "Resolution interposing no objection for the construction of Building as applied by Mr. Bruce T. Recidoro located at Purok 4, Barangay Salvacion, Bacon District, Sorsogon City;
4. Notarized Affidavit of perimeter neighbors Julio D. Dellosa, Jr., Nora J. Pura, Odelon A. Doctor and Natividad D. Dugayo interposing no objection on the said construction;

**WHEREAS**, a committee hearing was conducted for the purpose last May 28, 2021 through teleconferencing inviting the presence of Mr. Bruce T. Recidoro, Engr. Jolan Aquirre, Building Official and Members of the Committee on Land Use;

**WHEREAS**, initial scrutiny of the documents presented before the committee depicts compliance, crucial thereof is the barangay resolution interposing no objection on the said construction;

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution interposing no objection on the application for building permit of Mr. Bruce T. Recidoro for the construction of Poultry House located at Barangay Salvacion, Bacon District, Sorsogon City;
