RESOLUTION ENCOURAGING SORECO I AND SORECO II TO PROPOSE FOR A DIRECT PURCHASE OF ELECTRIC POWER SUPPLY FROM ENERGY DEVELOPMENT CORPORATION (EDC).

WHEREAS, pending before the 7th City Council is the Proposed Tanawon Geothermal Power Plant (TGPP) dated September 16, 2020;

WHEREAS, previous deliberation thereof was made before the 7th City Council during the October 06, 2020 AND October 27, 2020 Regular Session wherein members of city council expressed their respective comments on the matter;

WHEREAS, on May 28, 2021, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City issued a follow up letter relative to the Proposed Tanawon Geothermal Power Plant, thus the 7th City Council hereunder expressed their collective stand on the matter to wit;

- 1. That Energy Development Corporation (EDC) enters into a Direct Purchase of Electric Power Supply Agreement with preferential rates with SORECO I and SORECO II;
- 2. That in case of natural calamities, Sorsogon City being a host local government unit shall enjoy preference during restoration of power supply;
- 3. That Energy Development Corporation (EDC) submits their written Corporate Social Responsibility before the Sangguniang Panlungsod;

WHEREAS, cognizant of the foregoing premise, the 7th City Council deemed it necessary to pass a resolution encouraging SORECO I and SORECO II to propose for a direct purchase of Electric Power Supply from Energy Development Corporation (EDC);

NOW THEREFORE, on incidental motion of **City Councilor Fernando David H. Duran, III** duly seconded by **City Councilor Nestor J. Baldon** resolve as it is hereby resolved to encourage SORECO I and SORECO II to propose for a direct purchase of Electric Power Supply from Energy Development Corporation (EDC);
