RESOLUTION APPROVING THE FOUR (4) APPLICATIONS FOR CANCELLATION OF TRICYCLE FRANCHISE AND THEREBY AUTHORIZING QUALIFIED APPLICANTS TO SUBSTITUTE OR REPLACE THE FORMER HOLDERS THEREOF TO OPERATE TRICYCLE-FOR-HIRE IN THE CITY OF SORSOGON UNDER THE SAME FRANCHISE, MOTORCYCLE UNIT AND ROUTE OF OPERATION AS ALLOWED UNDER SECTION 13 OF CITY ORDINANCE NO. 22, SERIES OF 2020 OTHERWISE KNOWN AS THE “SORSOGON CITY NEW TRICYCLE FRANCHISE CODE OF 2020”

WHEREAS, the following were applied for dropping/cancellation of Tricycle Franchise due to the demise of the holders thereof with their respective Death Certificate attached and made integral part hereof, to wit:

1. **CECILLO D. DESCALLAR** of Barangay San Roque, Bacon District, Sorsogon City, died on August 4, 2010, a grantee of a Tricycle Franchise No. COS-2014-1220/Tricycle Franchise Plate No. 0825 for Tricycle-for-Hire Service with the route, valid up to May 27, 2017 and with the following technical description, to wit:

3. **CELSO J. RENORIA** of Barangay Sirangan, East District, Sorsogon City, died on February 2, 2018, a grantee of a Tricycle Franchise No. COS-2015-0532/Tricycle Franchise Plate No. 0588 for Tricycle-for-Hire Service with the route Poblacion Sorsogon City, valid up to February 12, 2018 and with the following technical description, to wit:

4. **NERISSA L. PIOPONGCO** of Barangay Ticol, West District, Sorsogon City, died on October 31, 2020, a grantee of a Tricycle Franchise No. 2707/Tricycle Franchise Plate No. 2707 for Tricycle-for-Hire Service with the route Poblacion/SCTT to Guinlajon and Basud (GUINPABTODA), valid up to August 10, 2025 and with the following technical description, to wit:

WHEREAS, Section 13 of City Ordinance No. 22-2020 (“Sorsogon City New Tricycle Franchise Code of 2020”) provides:

SECTION	13	VALIDITY OF FRANCHISE
---------	----	-----------------------

Any franchise shall remain valid for a period three (3) years from the date of its issuance and shall be renewed on its anniversary date. If the anniversary date falls on a Saturday, Sunday or holiday or on the occasion of declared calamity the renewal shall be on the next working day immediately after.

The inaction of the grantee for a period of six (6) months after the expiration of tricycle franchise shall cause an automatic revocation of the privilege granted after 2 (two) notices.

Within six (6) months from the death of the franchise holder, the Certificate of Franchise shall be surrendered to the Sangguniang Panlungsod through CTFRO. The surviving spouse or any of his/her children shall be the priority applicant for the said recalled franchise. Failure to report and surrender the said franchise within the prescribed period shall be forfeited in favor of the city government and may be awarded to qualified waiting applicant.

WHEREAS, NANCY D. DOMA, resident of Barangay San Roque, Bacon District, Sorsogon City, heir of the deceased Cecillio D. Escallar, **JOY D. LLODORES**, resident of Barangay Balogo, East District, Sorsogon City, heir of the deceased Juanito D. Dulva, **RYAN D. RENORIA**, resident of Barangay Sirangan, East District, Sorsogon City, heir of the deceased Celso J. Renoria and **JANICE REA P. JERESANO**, resident of Barangay Ticol, West District, Sorsogon City, heir of the deceased Nerissa L. Piopongco, applied to respectively substitute or replace their deceased family member in conformity with the provisions here above stated;

WHEREAS, the 7th City Council finds the herein applications to be meritorious and they are qualified to operate Tricycle-for-Hire in the City of Sorsogon under the same franchise, motorcycle unit and route of operation as allowed under Section 13 of City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise Code of 2020".

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Ralph Walter R. Lubiano**, resolved as it is hereby resolve to approve the four (4) applications for cancellation of tricycle franchise and thereby authorizing priority applicants to substitute or replace the former holders thereof to operate Tricycle-for-Hire in the City of Sorsogon under the same franchise, motorcycle unit and route of operation as allowed under Section 13 of City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise code of 2020".

RESOLVED FURTHER, resolved further that copies of this resolution be furnished to all concerned for their information and guidance.
