**RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ACCEPT THE DONATION OF SM PRIME HOLDINGS INC. OF A PORTION OF THEIR PROPERTY INTENDED FOR THE CONSTRUCTION OF A BY-PASS ROAD SITUATED AT BARANGAY BALOGO, EAST DISTRICT, SORSOGON CITY**

**WHEREAS**, the Department of Public Works and Highways (DPWH) through its District Engineering Office in Sorsogon City has a By-Pass Road construction project that passed over properties situated at Barangay Balogo, East District, Sorsogon City in order to alleviate the traffic condition in the city;

**WHEREAS**, the DPWH has requested the city government's assistance in securing the Right-of-Way over the properties affected by the By-Pass Road;

**WHEREAS**, the Donor (SM Prime Holdings Inc.) owns a parcel of land consisting of One Hundred Thirty Two Thousand and Three Square Meters (132,003 sq. m.), located at Barangay Balogo, East District, Sorsogon City;

**WHEREAS**, the donor has agreed to donate a portion of its property for an area of Ten Thousand One Hundred Fifty-Two Square Meters (10,152 sq. m.) where a portion of a By-Pass Road will be constructed;

**WHEREAS**, the 7<sup>th</sup> City Council hereby authorize the Local Chief Executive to accept the donation of the SM Prime Holdings Inc. under circumstances and conditions favorable to the best interest of the City Government of Sorsogon;

**NOW THEREFORE**, on motion of **Hon. Franco Eric O. Ravanilla** duly seconded by **Hon. Lorenz S. Abenion**, resolved as it is hereby resolve to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to accept the donation of the SM Prime Holdings Inc. of a portion of their property intended for the construction of a by-pass road situated at Barangay Balogo, East District, Sorsogon City.
