RESOLUTION RESPECTFULLY REQUESTING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO PROVIDE ADDITIONAL FUNDS FOR COVID 19 PANDEMIC RELATED EFFORTS AND PROGRAMS OF THE 64 BARANGAYS IN THE CITY OF SORSOGON

WHEREAS, Section 4, Par. (1) of City Ordinance No. 14-2021 otherwise known as the "Mandatory wearing of face mask, face shields and observance of Social/Physical Distancing Ordinance of 2021" provides that the ordinance shall be implemented by the Barangay officials and their Barangay Tanods, the PNP-Sorsogon City and TMECS/SK3/Public Order and Safety Office through the issuance of City Ordinance Violation Citation Tickets;

WHEREAS, Section 8, Par. (1) of City Ordinance No. 13-2021 otherwise known as the "Sorsogon City Emergency Curfew Ordinance of 2021 AMID COVID 19" likewise provides that the

said ordinance shall be implemented by the Barangay officials and their Barangay Tanods, the PNP-Sorsogon City and TMECS/SK3/Public Order and Safety Office through the issuance of City Ordinance Violation Citation Tickets;

WHEREAS, Section 6(e) of Republic Act No. 11332, "The Mandatory Reporting of Notifiable Diseases and Health Events of Public Health Concern Act," provides that local governments have the authority to conduct and enforce disease surveillance and response systems, epidemic/outbreak and epidemiologic investigations, and rapid containment, quarantine and isolation, disease prevention and control measures;

WHEREAS, the present situation of Sorsogon City wherein surge of Covid 19 cases were reported and then placed in the high-risk category, requires stringent measures and strict observance of the minimum health and safety protocols;

WHEREAS, based on Section 16 of the Local Government Code, every local government unit has the implied power to do all things necessary, appropriate, or incidental to govern efficiently and effectively, promote general welfare, promote health and safety, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, the measure aims to request Hon. City Mayor Ma. Ester E. Hamor to provide additional funds for Covid 19 Pandemic related efforts and programs of the 64 barangays in the city of Sorsogon, being one of the chief enforcers of the aforesaid ordinances and other health protocols amid Covid 19;

WHEREAS, this measure likewise requests the Hon. City Mayor Ma. Ester E. Hamor to further allow the barangays to utilize such additional funds for financial assistance for barangay enforcers, daily monitoring and enforcement activities and other similar Covid 19 response efforts, programs and activities of the barangays;

NOW THEREFORE, on motion of **Hon. Ma. Teresa D. Perdigon**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolve as it is hereby resolved to respectfully request Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to provide additional funds for Covid 19 Pandemic related efforts and programs of the 64 barangays in the city of Sorsogon.
