# Resolution No. 186, Series of 2021 (Hon. Lorenz S. Abenion)

RESOLUTION ENJOINING THE 64 BARANGAY SK COUNCILS TO SUPPORT THEIR RESPECTIVE BARANGAYS IN THE EFFECTIVE IMPLEMENTATION AND ENFORCEMENT OF CITY ORDINANCE NO. 13-2021 (SORSOGON CITY EMERGENCY CURFEW ORDINANCE OF 2021 AMID COVID 19), CITY ORDINANCE NO. 14-2021 (MANDATORY WEARING OF FACE MASK, FACE SHIELDS AND OBSERVANCE OF SOCIAL/PHYSICAL DISTANCING ORDINANCE OF 2021) AND COVID 19 RELATED EXECUTIVE ORDERS OF HON. CITY MAYOR MA. ESTER E. HAMOR

**WHEREAS,** Section 4, Par. (1) of City Ordinance No. 14-2021 otherwise known as the "Mandatory wearing of face mask, face shields and observance of Social/Physical Distancing Ordinance of 2021" provides that the aforesaid ordinances shall be implemented by the Barangay officials and their Barangay Tanods, the PNP-Sorsogon City and TMECS/SK3/Public Order and Safety Office;

WHEREAS, Section 8, Par. (1) of City Ordinance No. 13-2021 otherwise known as the "Sorsogon City Emergency Curfew Ordinance of 2021 AMID COVID 19" likewise provides that the said ordinances shall be implemented by the Barangay officials and their Barangay Tanods, the PNP-Sorsogon City and TMECS/SK3/Public Order and Safety Office through the issuance of City Ordinance Violation Citation Tickets;

WHEREAS, Section 6(e) of Republic Act No. 11332, "The Mandatory Reporting of Notifiable Diseases and Health Events of Public Health Concern Act," provides that local governments have the authority to conduct and enforce disease surveillance and response systems, epidemic/outbreak and epidemiologic investigations, and rapid containment, quarantine and isolation, disease prevention and control measures;

**WHEREAS,** the present situation of Sorsogon City wherein surge of Covid 19 cases were reported and then placed in the high-risk category, requires stringent measures and strict observance of the minimum health and safety protocols;

**WHEREAS,** the Barangay SK Councils, being part of barangay governance shall actively participate in these noble undertakings;

**WHEREAS,** the public shall be more vigilant with the fake news and misinformation circulating related to the implementation and enforcement of the minimum public health standards;

WHEREAS, the 64 Barangay SK Councils of the city of Sorsogon are hereby enjoined to support their respective barangays in its massive information drive campaign related to the implementation and enforcement of City Ordinance No. 13-2021, City Ordinance No. 14-2021 and Covid 19 related Executive Orders of the city government;

NOW THEREFORE, on motion of City Councilor Lorenz Abenion duly seconded by City Councilor Rebecca Aquino, resolve as it is hereby resolved to enjoin the 64 Barangay SK Councils to support their respective barangays in the effective implementation and enforcement of City Ordinance No. 13-2021 (Sorsogon City Emergency Curfew Ordinance of 2021 Amid Covid 19), City Ordinance No. 14-2021 (Mandatory Wearing of Face Mask, Face Shields and Observance of Social/Physical Distancing Ordinance of 2021) and Covid 19 related Executive Orders of the Hon. City Mayor Ma. Ester E. Hamor.
