RESOLUTION REQUIRING THE CITY TRICYCLE FRANCHISING REGULATORY OFFICE TO INCLUDE THE PROOF OF MEMBERSHIP AS AMONG THE REQUIREMENT IN THE RENEWAL OF TRICYCLE FRANCHISES ISSUED BY THE SANGGUNIANG PANLUNGSOD.

WHEREAS, as per clamor of association presidents of various authorized tricycle for hire routes issued by a valid franchise by the Sangguniang Panlungsod, Proof of Membership should be included as a requirement in the renewal of tricycle for hire in the territorial jurisdiction of the City of Sorsogon;

WHEREAS, per discussion made during the regular session of the 7th City Council, aforementioned clamor maybe given due course as long as the same is not subjected to abuse and shall comply with pertinent provisions of relevant local laws;


