RESOLUTION RESPECTFULLY REQUESTING THE CITY VETERINARY OFFICE TO CONDUCT PEST CONTROL ACTIVITIES TO TOTALLY ELIMINATE FLY INFESTATION AT THE CITY GOVERNMENT'S SLAUGHTER HOUSE LOCATED AT SITIO MADAN-AN, BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY

WHEREAS, reports have been brought out to the Sangguniang Panlungsod that fly infestation at the city government's Slaughter House located at Sitio Madan-an, Barangay Bibincahan had tremendously affect the sanitation of the area;

WHEREAS, fly infestation can happen in different areas of any facility wherein some fly species will breed in areas where organic matter builds up or where plumbing is found;

WHEREAS, some fly species prefer to breed outside as a result of the conditions they are attracted to such as buildings with specific odors that are equally as attractive when searching for food and water resources;

WHEREAS, once inside, flies will land on surfaces, products, and food and spreads bacteria and pathogens they carry on their bodies, leading to product contamination and food poisoning;

WHEREAS, while flies are known as vectors of disease, their presence can also indicate a sanitation issue that needs attention for fly infestations at the slaughter house that handle raw food can put food safety and reputation at risk;

WHEREAS, the City Veterinary Office is hereby requested to conduct a pest control activities within the 200 meter circumferential area of the slaughter to totally eliminate the aforesaid fly infestation;

NOW THEREFORE, on motion of **Hon. Jo Abegail C. Dioneda**, duly seconded by **Hon. Nestor J. Baldon**, resolved as it is hereby resolve to respectfully request the City Veterinary Office to conduct pest control activities to totally eliminate fly infestation at the city government's Slaughter House located at Sitio Madan-an, Barangay Bibincahan, East District, Sorsogon City.
