RESOLUTION INTERPOSING NO OBJECTION FOR THE APPLICATION OF JETTI PETROLEUM GAS STATION TO CONSTRUCT AND OPERATE A FUEL REFILLING STATION TO BE BUILT IN LOT 3103-A AND 3105-C UNDER TCT NO. 083-2019000010 AND T-49789 LOCATED AT RIZAL STREET, BARANGAY PIOT, WEST DISTRICT, SORSOGON CITY.

WHEREAS, on May 06, 2021, Engr. Simplicio L. Guinto, General Manager, SLG wrote a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City thru the Hon. Nestor J. Baldon, City Councilor respectfully requesting for the passage of a Resolution Interposing No Objection for the Application of Jetti Petroleum Gas Station to Construct and Operate a Fuel Refilling Station to be Built in Lot 3103-A and 3105-C Under TCT No. 083-2019000010 and T-49789 located at Rizal Street, Barangay Piot, West District, Sorsogon City;

WHEREAS, aforementioned letter was among the items deliberated upon by the 7th City Council during the May 25, 2021 Regular Session of the 7th City Council and was referred to the Committee on Land Use, Urban Planning and Housing;

WHEREAS, as per consensus of the committee, the Office of the Secretary to the Sangguniang Panlungsod Secretariat to inform the applicant to submit pertinent documents for the committee's perusal wherein documents was submitted in installment basis evidenced by the Affidavit of Non objection of Neighboring residents in relation to the construction of JETTI Petroleum Station bearing June 11, 2021 as the date of Notarization.

WHEREAS, for purposes of this resolution, hereunder are the submitted documents per compliance of the applicant;

- 4. Environmental Compliance Certificate (ECC-OL-RO5-2019-0170) issued to Jetti Petroleum Inc. Refilling Station Project to be located at Barangay Piot, Sorsogon City, Province of Sorsogon issued by Engr. Maria Socorro A. Abu, PhD, OIC Regional Director dated August 08, 2019;
- 5. Environmental Compliance Certificate (Issued under Presidential Decree 1586) (ECC OL-RO5-2019-0170) stating that JETTI Petroleum Inc. represented by its Manager, Mr. Jonnel P. De Llamas is granted an Environmental Compliance Certificate (ECC) for the Proposed JETTI Petroleum Inc. Refilling Station to be located in Barangay Piot, Sorsogon City, Province of Sorsogon, by the Department of Environment and Natural Resources through the Environmental Management Bureau (EMB);
- 6. Photocopy of the Construction Safety and Health Program issued Clyde L. Tamayo, Project Manager, Jetti Petroleum Inc. issued by the department of Labor and Employment (DOLE), Regional Office V dated May 12, 2021;
- 7. Photocopy of Lease Contract entered into by and between Charles P. Clemente and JETTI Petroleum, Inc.;
- 8. Photocopy of Construction Agreement by and between Jetti Petroleum and S.A. Tamayo Construction;
- 9. Lot Plan of the Proposed Jetti Petroleum Construction;
- 10. Photocopy of Secretary's Certificate issued by Lone Marian D. Garcia, Corporate Secretary, Jetti Petroleum, Inc. stating that Engr. Simplicio Guinto be authorized to process and transact business in relation to Jetti Petroleum Refilling Station Construction in Barangay Piot, Sorsogon City, Province of Sorsogon;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a Resolution Interposing No Objection for the Application of Jetti Petroleum Gas Station to Construct and Operate a Fuel Refilling Station to be Built in Lot 3103-A and 3105-C Under TCT No. 083-2019000010 and T-49789 located at Rizal Street, Barangay Piot, West District, Sorsogon City;
