RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE – REGIONAL FIELD OFFICE 5 REPRESENTED BY DIR. RODEL P. TORNILLA RELATIVE TO THE KADIWA NI ANI AT KITA CENTER IN THE CITY OF SORSOGON

WHEREAS, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City on its letter/Transmittal No. 36-2021, dated June 22, 2021, addressed to Hon. Mark Eric C. Dioneda, City Mayor, Sorsogon City and to the honorable members of the 7th City Council, requested to pass a resolution authorizing her to enter into a Memorandum of Agreement (MOA) with the Department of Agriculture – Regional Field Office 5 represented by Dir. Rodel P. Tornilla relative to the KADIWA ni Ani at Kita Center in the city of Sorsogon;

WHEREAS, the project aims to help improve the lives of the Filipino people by promoting the innovative agricultural production and marketing programs designed to generate livelihood opportunities for farmers and fisherfolk;

WHEREAS, the City Government expressed its intention to avail of the project through the City Agricultural Services Office for the same shall pave the way to ensure food availability and shall empower the local agriculture sector;

WHEREAS, the program further aims to empower the farmers and fisherfolk by increasing their participation in the agricultural supply chain through establishing trading centers to improve productivity;

WHEREAS, the KADIWA ni Ani at Kita Center will provide a venue for farmers. Livestock/swine/poultry raisers and fisherfolk involved in production, processing and marketing, trade their products directly to clients and institutional buyers and not through the multi-levels of middlemen and/or a place where farmers, fisherfolk and traders can congregate;

WHEREAS, the City Government of Sorsogon provided the lot located at Barangay Sampaloc, East District, Sorsogon City for the establishment of the KADIWA Center, which is strategically located and accessible to both buyers and sellers of agricultural products;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Ralph Walter R. Lubiano**, resolved as it is hereby resolve to authorize Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Department of Agriculture – Regional Field Office 5 represented by Dir. Rodel P. Tornilla relative to the KADIWA ni Ani at Kita Center in the City of Sorsogon.
