

RESOLUTION RESPECTFULLY REQUESTING THE MANAGEMENT OF SORECO II TO MAINTAIN THEIR RECONNECTION FEE WITH A FIXED RATE AND SHALL NOT BE SUBJECTED FOR INCREASE BASED ON PRIOR POWER CONSUMPTION **HISTORY** 

WHEREAS, the Sangguniang Panlungsod was in receipt of complaints and reports of sudden increase in SORECO II's reconnection fee;

WHEREAS, tight power supply conditions in the Luzon grid pushed up SORECO II rates in billing statements that many could not be able to pay and subsequently may be disconnected with electricity power;

WHEREAS, earlier forecasts have signified that tight supply conditions, primarily in the biggest power grid of Luzon, may persist until the month of August and may cause

disconnection of power due to power rate increase that many may not be able to afford and pay the same;

**WHEREAS**, the poor economic situation of every family today due to pandemic should always be put into consideration;

**WHEREAS**, such situation shall not be further weaken by any additional burden such as increase in the reconnection fee of SORECO II which could be humanitarianly considered;

**NOW THEREFORE**, on motion of **Hon. Hilario D. Dioneda**, duly seconded by the body, resolved as it is hereby resolve to request the management of SORECO II to maintain their reconnection fee with a fixed rate and shall not be subjected for increase based on prior power consumption history.

**RESOLVED FURTHER**, that copies of this resolution be furnished to all concerned for their information.
