RESOLUTION ENJOINING THE CITY PLANNING AND DEVELOPMENT OFFICE TO CONDUCT A FEASIBILITY STUDY ON THE POSSIBLE EXPANSION AND/OR EXTENSION OF THE CITY PUBLIC MARKET OR OF THE DEVELOPMENT OF SATELLITE MARKETS

WHEREAS, the Committee on Market Affairs conducted a hearing regarding the proposal thru an ordinance of expanding the City Public Market thru expropriation;

WHEREAS, after the first hearing, it issued, duly approved by the 7th City Council, a Committee Report regarding its important findings and recommendations for purposes of legislation;

WHEREAS, the Committee Report found out that there is no existing economic data as basis for the necessity of expanding the City Public Market, the development of which is identified in the 10 Point Agenda by the honorable administration of the city;

WHEREAS, identified as primary economic data are the following:

1. The volume of public transactions in the public markets (including its segregation among the different sections)
2. The consequent history of such transaction divided into three phases: (1) prior to the pandemic, (2) the pandemic stage, and (3) the post pandemic stage.
3. The total transaction in the city compared to the total public market transactions.
4. The population of vendors of all classification (its segregation to legitimate and ambulant, and to the different sections), this must include the history of this population divided into three phases similar to that of the history of transactions.

WHEREAS, transactions (total, public and private) should be conceptualized to mean the interaction of buyers and sellers in a specific time and place and estimating thereon not just the volume of sales of these transactions, but also, the population involved in such transactions;

WHEREAS, such feasibility study enjoined upon the CPDO should also include the following:

1. The necessary costs of such proposed expansion.
2. The size that it will involve.
3. The strategic locations of the expansion.
4. The history of capital outlay versus the revenue generated on the city's public markets, including forecasts on revenue generation once expansion is not implemented and when it is implemented.

NOW THEREFORE, on motion of **Hon. Joven Francis J. Laura**, duly seconded by **Hon. Nestor J. Baldon**, resolve as it is hereby resolved to enjoin the City Planning and Development Office (CPDO) to conduct a feasibility study on the possible expansion and/or extension of the City Public Market or of the development of barangay markets.

RESOLVED FURTHER, that copies of this resolution be furnished to all concern for their information and guidance.
