RESOLUTION RESPECTFULLY REQUESTING THE MANAGEMENT OF SORSOGON II ELECTRIC COOPERATIVE (SORECO II) TO TEMPORARILY SUSPEND THE IMPLEMENTATION OF POWER METER READER REQUIREMENT FOR THE STREET LIGHTS POWER CONSUMPTION OF ALL BARANGAYS IN THE CITY OF SORSOGON

WHEREAS, barangays in the City of Sorsogon were in receipt of a letter from the Sub-Office Managers of SORECO II informing them the proposed power meter reader requirement for the street lights in the barangays in line with the cooperative's policies for the aforesaid operation;

WHEREAS, the letter prescribed August 2021 as deadline within which the barangays have to comply with;

WHEREAS, failure on the part of the barangays to comply with the said policy would result to power disconnection of street lights in all barangays in the city of Sorsogon;

WHEREAS, barangay funds were already appropriated to particular projects, programs and activities of the barangay for 2021 budget operation, the bulks of which are mostly intended for the government's efforts to respond to Covid 19 Pandemic;

WHEREAS, procurement of power meter reader of the barangays is not among listed in respective barangay's Project Procurement Management Plan 2021;

WHEREAS, premises considered, it is most respectfully requested that the implementation of power meter reader requirement for the street lights power consumption of all barangays in the City of Sorsogon be temporarily suspended until next year when the said project/activity could be already included in the barangay budgets;

NOW THEREFORE, on motion of **Hon. Ma. Teresa D. Perdigon**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolve as it is hereby resolved to respectfully request the management of Sorsogon II Electric Cooperative (SORECO II) to temporarily suspend the implementation of power meter reader requirement for the street lights power consumption of all barangays in the City of Sorsogon.
