HAMOR FOR BEING THE 1<sup>st</sup> AND ONLY CITY LGU IN BICOL REGION TO BE OFFICIALLY CERTIFIED BY CERTIFICATION INTERNATIONAL PHILIPPINES, INC. (CIPI) TO ISO 9001: VERSION 2015 FOR ITS QUALITY MANAGEMENT SYSTEM COVERING ALL FUNCTIONAL AREAS AND NO EXCLUSIONS TO THE REQUIREMENTS OF THE INTERNATIONAL STANDARD

WHEREAS, the Hon. City Mayor Ma. Ester E. Hamor, in line with the efforts of the city government of Sorsogon to be certified under ISO: 9001 Version 2015, the City Mayor issued Executive Order No. 34, Series of 2020, entitled "An order mandating the strict adherence of the city government to ISO: 9001 Quality Management System Standards and the fulfillment of its necessary requirements";

**WHEREAS**, Executive Order No. 34, Series of 2020 and Sangguniang Panlungsod Resolution No. 157, Series of 2021 approved and adopted the Quality Policy of the city government of Sorsogon, stated as follows;

**WHEREAS**, on June 17-18, 2021, all offices in the Executive and Legislative Department of the city government of Sorsogon were subjected to final audit by the Certification International Philippines, Inc. (CIPI) to ISO 9001: Version 2015;

**WHEREAS**, on July 12, 2021, the Certification International Philippines, Inc. (CIPI) confirmed that the city government of Sorsogon is now officially certified to ISO 9001: Version 2015 for its Quality Management System;

**WHEREAS**, The City Government of Sorsogon is the first City LGU in the Bicol Region to be certified in its Business Operations and Public Service Delivery with the following distinctions:

- Covers all Functional Areas
- No exclusions to the requirements of the International Standard
- Certified in time of pandemic crisis
- Fifteen (15) working days gap between Stage 1 and Stage 2 Audits
- Record-breaking ZERO (o) working day submission of corrective actions from date of receipt of the Audit Report (Submission of CAs done on the day audit report was received)

**NOW THEREFORE**, on motion of **Hon. Rebecca D. Aquino** duly seconded by **Hon. Fernando David H. Duran**, **III**, resolved as it is hereby resolve to congratulate and commend the officials and employees of the City Government of Sorsogon under the leadership of Hon. City Mayor Ma. Ester E. Hamor for being the 1<sup>st</sup> and only City LGU in the Bicol Region to be officially certified by Certification International Philippines, Inc. (CIPI) to ISO 9001: Version 2015 for its Quality Management System covering all functional areas and no exclusions to the requirements of the international standard.
