RESOLUTION RESPECTFULLY REQUESTING THE SORECO II MANAGEMENT TO BE LENIENT IN DISCONNECTING ELECTRICITY POWER SUPPLY AGAINST CITY AND BARANGAY GOVERNMENTS AND OTHER GOVERNMENT ACCOMODATIONS AND SERVICE FACILITIES

WHEREAS, this measure emanates from the Manifesto of the Liga ng mga Barangay-Sorsogon City Chapter in response to the letter from SORECO II informing them the proposed power meter reader requirement for the street lights in the barangays and failure on the part of the barangays to comply with the said policy would result to power disconnection of street lights;

**WHEREAS**, government funds were already appropriated to particular projects, programs and activities and the bulks of which are mostly intended and defray expenses for the government's efforts to respond to Covid 19 Pandemic;

WHEREAS, despite the limited available allocation the Barangay Government still managed to perform their duties on serving the public and its constituents;

WHEREAS, electricity power supply is one of the factors needed in the day to day transaction of the Barangay Government and other government accommodations and service facilities;

WHEREAS, LGU's and other government facilities are sometimes caught with unexpected circumstances that cause its transactions to go beyond their due dates such as the current skeletal workforce, bank lockdowns, employees self isolation or quarantine process and other similar causes;

WHEREAS, premises considered and circumstances beyond control, disconnection of power supply against city and barangay government and of the government accommodations and service facilities should be accorded with leniency so as not to deprived the public of its services;

NOW THEREFORE, on motion of Hon. Nestor J. Baldon, duly seconded by Hon. Fernando David H. Duran, III, resolved as it is hereby resolve to respectfully request the SORECO II Management to be lenient in disconnecting electricity power supply against city and barangay governments and other government accomodations and service facilities
