RESOLUTION RESPECTFULLY REQUESTING THE SORECO II MANAGEMENT TO BE LENIENT IN DISCONNECTING ELECTRICITY POWER SUPPLY ON HOUSEHOLDS WITH BELOW 100 KWH CONSUMPTION AND PROVIDE THEM WITH SUFFICIENT TIME TO MAKE PAYMENT THEREOF

WHEREAS, because of the tight power supply conditions in the Luzon grid pushed up SORECO II rates in June billing statements, with an earlier forecast that this may persist until August this year, which every member consumer of the Cooperative finds the same difficult to dealt with;

WHEREAS, considering the economic hardship suffered by every family household in the City of Sorsogon due to Covid 19 pandemic, it is our solemn duty to extend them with sympathy and compassionate treatment to at least lessen their burden from their day to day struggle;

WHEREAS, the 7th City Council is humbly suggesting for additional weeks of extension from due dates or any new payment scheme to avoid further disconnection;


WHEREAS, households with below 100 kwh consumption are those families that are greatly affected by the pandemic;

NOW THEREFORE, on motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by **Hon. Fernando David H. Duran, III**, resolved as it is hereby resolve to respectfully request the SORECO II Management to be lenient in disconnecting electricity power supply on households with below 100 kwh consumption and provide them with sufficient time to make payment thereof.
