**RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ACCEPT THE TERMS AND CONDITIONS SET FORTH BY THE DEPARTMENT OF EDUCATION RELATIVE TO THE UTILIZATION OF VARIOUS SCHOOLS IN THE CITY OF SORSOGON AS QUARANTINE FACILITIES IN LINE WITH THE CITY GOVERNMENT'S CONTINUING EFFORTS TO CURTAIL THE SPREAD OF COVID 19**

**WHEREAS**, Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City on its letter/Transmittal No. 40-2021, dated June 25, 2021, addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and to the Honorable Members of the 7<sup>th</sup> City Council, requested to pass a resolution authorizing her to accept the terms and conditions set forth by the Department of Education relative to the utilization of various schools in the city of Sorsogon as quarantine facilities in line with the city government's continuing efforts to curtail the spread of Covid 19;

**WHEREAS**, the school was chosen to be isolation facility for the reason that it can provide the needed space and required essential facilities for a quarantine area;

**WHEREAS**, in order to facilitate such utilization, there is a need to agree on the terms and conditions for its use which shall include the payment and maintenance of utilities among others;

**WHEREAS**, considering that there may be further need to use other schools within the city of Sorsogon as a quarantine facility, it is therefore just and proper to authorize the Local Chief Executive to expressly accept the terms and conditions thereof;

**NOW THEREFORE**, on motion of **Hon. Joven Francis J. Laura** duly seconded by Hon. Nestor J. Baldon, resolved as it is hereby resolve to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to accept the terms and conditions set forth by the Department of Education relative to the utilization of various schools in the City of Sorsogon as quarantine facilities in line with the city government's continuing efforts to curtail the spread of Covid 19.
