**RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON TO ENTER INTO A PARTNERSHIP AGREEMENT WITH THE COMMISSION ON POPULATION AND DEVELOPMENT – REGION V REPRESENTED BY ITS REGIONAL DIRECTOR JOYCE DELA PAZ – HILVANO RELATIVE TO THE IMPLEMENTATION OF THE NATIONAL PROGRAM ON POPULATION AND FAMILY PLANNING (NPPFP) IN THE CITY OF SORSOGON**

**WHEREAS**, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City on its letter/Transmittal No. 41-2021, dated June 28, 2021, addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City and to the Honorable Members of the 7<sup>th</sup> City Council, requested to pass a resolution authorizing her to enter into a partnership agreement with the Commission on Population and Development – Region v represented by its Regional Director Joyce Dela Paz – Hilvano relative to the implementation of the National Program on Population and Family Planning (NPPFP) in the City of Sorsogon;

**WHEREAS**, in line with the full implementation of RA 10354 otherwise known as the “Responsible Parenthood and Reproductive Health Act of 2012” (RPRH Law), the City Government of Sorsogon recognizes the significance of the attainment of demographic dividend as a key development objective to improve the socioeconomic potential of the country;

**WHEREAS**, the RPRH Law mandates the Local Government Units to ensure the provision of the appropriate level of care, of the full range of responsible parenthood and reproductive health care services, including modern family planning methods, both natural and artificial, to all clients regardless of age, sex, gender, disability, marital status or background;

**WHEREAS**, in support of the implementation of the NPPFP, DILG Circular No. 2019-100 was issued to specifically enjoin all LGUs to designate or appoint their respective Local Population Officers and mobilize all relevant local offices and instrumentalities for the intensified implementation of the NPPFP, particularly at the community level;


**NOW THEREFORE**, on motion of **Hon. Danilo A. Deladia** duly seconded by **Hon. Fernando David H. Duran, III**, resolved as it is hereby resolve to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a partnership agreement with the Commission on Population and Development – Region v represented by its Regional Director Joyce Dela Paz – Hilvano relative to the implementation of the National Program on Population and Family Planning (NPPFP) in the city of Sorsogon.
