**RESOLUTION ISSUING TRICYCLE FRANCHISE TO THREE (3) QUALIFIED WAITING APPLICANTS FROM PREVIOUSLY CANCELLED/REVOKED TRICYCLE FRANCHISES UNDER SP RESOLUTION NO. 210, SERIES OF 2021 FOR VIOLATION OF SECTION 20 OF CITY ORDINANCE NO. 22, SERIES OF 2020 OTHERWISE KNOWN AS THE "SORSOGON CITY NEW TRICYCLE FRANCHISE CODE OF 2020"**

**WHEREAS**, SP Resolution No. 210, Series of 2021, approved on July 27, 2021 officially cancelled and revoked in favor of the city government of Sorsogon Tricycle Franchise No. 1050, Tricycle Franchise No. 4094 and Tricycle Franchise No. 0610 for violation of Section 20 of City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise Code of 2020";

**WHEREAS**, on July 30, 2021, the Tricycle Franchising Regulatory Office through the SP Committee on Tricycle Franchise endorsed the Three (3) qualified waiting applicants for the aforesaid cancelled/revoked tricycle franchises, to wit:

1. **MARK ANTHONY LAGAMAYO** of Barangay Pangpang, West District, Sorsogon City for Tricycle Franchise No. 1050/PTODA.
2. **INIGO D. DESTACAMENTO** of Barangay San Pascual, Bacon District, Sorsogon City for Tricycle Franchise No. 4095/PTODA.
3. **JAYSON E. ROJAS** of Barangay Salog, East District, Sorsogon City for Tricycle Franchise No. 0610/PTODA.

**WHEREAS**, Section 14 of City Ordinance No. 22-2020 ("Sorsogon City New Tricycle Franchise Code of 2020") provides that the Sangguniang Panlungsod shall issue/grant franchise to operate a motorized tricycle for hire to qualified persons who desire to provide transport service to the general public by means of a motorized tricycle for monetary consideration. Being a privilege, it can be revoked, cancelled or withdrawn unilaterally at any time upon reasonable grounds;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Lorenz S. Abenion**, resolved as it is hereby resolve to issue tricycle franchise to three (3) qualified waiting applicants from previously cancelled/revoked tricycle franchises under SP resolution No. 210, Series of 2021 for violation of Section 20 of City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise Code of 2020".
