RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT (MOA) ENTERED INTO BY THE CITY GOVERNMENT OF SORSOGON WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REPRESENTED BY ITS REGIONAL DIRECTOR LEO L. QUINTILLA RELATIVE TO THE SUPPLEMENTARY FEEDING PROGRAM (SFP)

WHEREAS, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City on its letter/Transmittal No. 43-2021, dated July 29, 2021, addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor, and to the Honorable Members of the 7th City Council, requested to pass a resolution for the ratification of the Memorandum of Agreement (MOA) entered into by the City Government of Sorsogon with the Department of Social Welfare and Development (DSWD) represented by its Regional Director Leo L. Quintilla relative to the Supplementary Feeding Program (SFP);

WHEREAS, the SFP is the provision of food in addition to the regular meals to target children ages 2-5 years old enrolled in the Child Development Center (CDCs) and Supervised Neighborhood Play (SNPs) as part of the DSWD's contribution to the Early Childhood Care and Development (ECCD) Program of the government;

WHEREAS, Section 4 (v), sub item (8) of RA 11469, otherwise known as the "Bayanihan to Heal as One" identified the SFP as one of the priority programs necessary or beneficial in order to address Covid-19 emergency;

WHEREAS, noting the limitation in the purchasing power of most families, SFP implementation during the implementation of community quarantine shall assist in addressing the issue of hunger and food security among Filipino children and prevent regression of the current national status of the beneficiaries;

WHEREAS, the MOA was perfected in order to facilitate the transfer of funds from the DSWD to the LGU intended for the implementation of a feeding program for qualified residents of the city of Sorsogon;

NOW THEREFORE, on motion of **Hon. Mary Ellen D. Jamisola** duly seconded by **Hon. Franco Eric O. Ravanilla**, resolved as it is hereby resolve to ratify the Memorandum of Agreement (MOA) entered into by the City Government of Sorsogon with the Department of Social Welfare and Development (DSWD) represented by its Regional Director Leo L. Quintilla relative to the Supplementary Feeding Program (SFP).
