RESOLUTION STRONGLY SUPPORTING BOARD RESOLUTION NO. 103, SERIES OF 2021 OF THE SORSOGON II ELECTRIC COOPERATIVE (SORECO II) ENTITLED "RESOLUTION APPROVING AND AUTHORIZING THE MANAGEMENT THRU GENERAL MANAGER ENGR. JOSEF ERWIN R. TABUENA TO DIRECT THE TP-BAC TO CONDUCT CSP FOR DOE AND NEA APPROVAL AND AUTHORIZING THE SAME TO ALLOCATE AND RELAEASE NECESSARY FUNDS RELATIVE THERETO, SUBJECT TO PROPER ACCOUNTING AND AUDIT POLICY/ RULES AND PROCEDURES

**WHEREAS,** just recently, SORECO II Member Consumers expressed discontent on the sudden spike in electricity bills wherein the 7<sup>th</sup> City Council immediately requested the presence of Engr. Josef Erwin R. Tabuena in a regular session in order to enlighten the City Council of the matter at issue;

**WHEREAS**, during the regular session conducted, Engr. Tabuena explained why and how the sudden surge happened and what available remedies can be implemented in order to hasten the problem;

**WHEREAS,** among others contained in the aforementioned Board Resolution No. 103, Series of 2021 of SORECO II Board wherein after perusal of the same, the 7<sup>th</sup> City Council decided to support and endorse the matter to the Department of Energy (DOE) and National Electrification Administration (NEA);

NOW THEREFORE, on incidental motion of City Councilor Franco Eric O. Ravanilla, duly seconded by City Councilor Fernando David H. Duran III, resolved as it is hereby resolve to strongly support Board Resolution No. 103, Series of 2021 of the Sorsogon II Electric Cooperative (SORECO II) entitled "Resolution approving and authorizing the management thru General Manager Engr. Josef Erwin R. Tabuena to direct the TP-Bac to conduct CSP for DOE and NEA approval and authorizing the same to allocate and release necessary funds relative thereto, subject to proper accounting and audit policy/ rules and procedures.
