RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH DR. CLODOALDO G. LEOCADIO, JR., RELATIVE TO THE RELINQUISHMENT OF HIS RESIDENCE INCLUDING A GUEST HOUSE SITUATED WITHIN THE FORMER RURAL HEALTH UNIT (AMBERG) AT BARANGAY SAN JUAN (RORO), EAST DISTRICT, SORSOGON CITY IN FAVOR OF THE CITY GOVERNMENT AND THE LATTER SHALL IN RETURN PROVIDE ASSISTANCE TO DR. LEOCADIO FOR THE ESTABLISHMENT OF A ROAD RIGHT OF WAY

WHEREAS, the Hon. City Mayor Ma. Ester E. Hamor, on its letter/Transmittal No. 45-2021, dated August 12, 2021, addressed to Hon. City Vice Mayor Mark Eric C. Dioneda and to the honorable members of the 7th City Council, requested to pass a resolution authorizing Hon. City Mayor Ma. Ester E. Hamor to enter into a Memorandum of Agreement (MOA) with Dr. Clodoaldo G. Leocadio, Jr. MD, relative to the relinquishment of his residence including a guest house situated within the former Rural Health Unit (AMBERG) at Barangay San Juan (RORO), East

District, Sorsogon City in favor of the city government and the latter shall in return provide assistance to Dr. Leocadio for the establishment of a road right of way;

WHEREAS, the City Government of Sorsogon has plans for the improvement, constructions and other projects within the former Rural Health Unit (AMBERG) at Barangay San Juan (RORO), East District, Sorsogon City;

WHEREAS, the space and residence area presently occupied by Dr. Clodoaldo G. Leocadio, Jr. including the Guest House located inside the Amberg Area, are needed in the implementation of such improvement, construction and other projects of the City Government of Sorsogon;

WHEREAS, the Sangguniang Panlungsod, through the 6th City Council has approved Resolution No. 433, Series of 2018, dated September 4, 2018 authorizing then City Mayor Sally A. Lee to enter into a new Memorandum of Agreement with Dr. Clodoaldo G. Leocadio, Jr. with the provisions that the latter officially relinquish the use, possession and care of his present residence, including the Guest House and formally turns them over the City Government and the latter shall provide for the right of way to serve as ingress and egress from his relocated house to the nearest public road;

NOW THEREFORE, on incidental motion of **Hon. Franco Eric O. Ravanilla** duly seconded by **Hon. Joven Francis J. Laura**, resolved as it is hereby resolve to authorize Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with Dr. Clodoaldo G. Leocadio, Jr., relative to the relinquishment of his residence including a guest house situated within the former Rural Health Unit (AMBERG) at Barangay San Juan (RORO), East District, Sorsogon City in favor of the City Government and the latter shall in return provide assistance to Dr. Leocadio for the establishment of a road right of way.
