RESOLUTION ADOPTING THE CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 06, SERIES OF 2020 AND THEREBY ENACTING AN APPROPRIATION ORDINANCE FOR THE REALIGNMENT OF ONE MILLION (P 1,000,000.00) FROM 2019 20% DEVELOPMENT FUND ITEM NO. II-1 TO 2020 DEVELOPMENT FUND ITEM NO. III-3

**WHEREAS**, last March 9, 2020, the Local Development Council approved Resolution No. 01, Series of 2020 and the same was duly approved and adopted by the 7<sup>th</sup> City Council thru Resolution NO. 088, Series of 2020 and Appropriation Ordinance No. 04, Series of 2020, dated March 31, 2020;

**WHEREAS**, in the previously approved realignment of fund, the enhancement of shallow tube has an allocation of  $P_{1,218,536.86}$  for five (5) units of shallow tube wells;

**WHEREAS**, upon inspection, the five (5) shallow tube wells are in need of enhancement, thus, funding augmentation is therefore necessary for the purpose;

**WHEREAS**, the enhancement of these wells will contribute to the improvement of rice production in the areas and thereby helping the poverty alleviation programs of the city government of Sorsogon;

**WHEREAS**, the projects are identified as consistent with the priorities under the Local Development Plan and complements with the overall national and global goals and aspirations.

**NOW THEREFORE**, on motion of **Hon. Joven G. Laura**, duly seconded by **Hon. Rebecca D. Aquino**, resolved as it is hereby resolve to adopt the City Development Council (CDC) Resolution No. 06, Series of 2020 and thereby enacting an Appropriation Ordinance for the realignment of One Million (P1,000,000.00) Pesos from 2019 20% Development Fund Item No. II-1 (Improvement/expansion of multi-purpose hall @ 3 districts for medicine storage/warehouse) to 2020 Development Fund Item No. III-3 (Enhancement of shallow tube well).
