RESOLUTION APPEALING THE SORSOGON CITY WATER DISTRICT BOARD OF DIRECTORS TO INITIATE THE SUSPENSION OF IMPLEMENTATION OF TARIFF RATES ADJUSTMENT BY PRIME WATER INFRASTRUCTURE, INC. (PRIME WATER SORSOGON CITY).

WHEREAS, on April 2001 BOD Meeting of Sorsogon City Water District (SCWD), Prime Water Operations head for South Luzon (Quezon and Bicol) Engr. Ernesto M. Solis, Jr. thru Prime Water Sorsogon City Branch Manager Engr. Hendrickson E. Latonio presented its proposed 2021 Capital Expenditures (CAPEX) infusion amounting to more or less P 42 Million to wit;

WHEREAS, prior representations and appearances made by Sorsogon City Water District (SCWD) and Prime Water Sorsogon City revealed that Prime Water shall be subjected to Assessment by October of this year in consonance with the Joint Venture Agreement (JVA) entered into aforementioned parties;

WHEREAS, for purposes of protecting the interest of water consumers, pandemic issues in this trying times and the forthcoming assessment of Prime Water by October of this year, the 7th City Council deemed it necessary to pass a resolution appealing the Sorsogon City Water District Board of Directors to initiate the suspension of implementation of tariff rates adjustment by Prime Water Infrastructure, Inc. (Prime Water Sorsogon City);

NOW THEREFORE, on incidental motion of **City Councilor Franco Eric O. Ravanilla** duly seconded by **City Councilor Fernando David H. Duran, III,** resolve as it is hereby resolved to appeal the Sorsogon City Water District Board of Directors to initiate the suspension of implementation of tariff rates adjustment by Prime Water Infrastructure, Inc. (Prime water Sorsogon City);
